

Wireless Innovation Forum Procedure for Electronic Ballots

Version 2.0 14 September 2010

This document specifies the Wireless Innovation Forum procedure for electronic ballots at the Committee and Plenary level. Electronic ballots use the survey tool on the group portal and are announced by an email sent to the appropriate email list. The following procedure is used to develop and deliver the ballot via email and to review the results. Steps are intended to be performed by Wireless Innovation Forum staff unless otherwise noted.

- A. Construct the ballot using the Socious survey tool. In summary:
 - 1. Log into the portal; go to 'Surveys and Polls'
 - 2. Click 'Options', 'Survey Manager'
 - 3. To create a new survey, Click 'Actions', 'Create Internal Survey'.
 - 4. Enter administrative information, including title, description (include a link to the document in this description see Page 2, Letter D for instructions), the target group (principals & alternates, technical representatives, etc.), start and end dates, response per person (should be 1) whether survey is anonymous and whether or not respondents may enter subsequent changes, then click OK. Note: General Surveys are seen by everybody in the portal, so an INTERNAL survey should be used for most surveys that are created. A separate survey will need to be created for each group involved in voting; for example, if the survey goes to the principals and alternates and the technical representatives, an identical ballot will need to be created for each group and each group should be targeted as described above.
 - 5. Build the survey (see Attachment A)
 - 6. Click 'Accept'
 - 7. Follow steps 1 & 2 again to find the ballot you just created.
 - 8. Click 'View' to see the survey. Edits can be made here.
 - 9. When the survey is edited and ready, click 'Actions', 'Request Survey'. This will create a URL link for the survey. Note: if edits must be made after requesting a survey, click 'Actions', 'Unrelease Survey', make the changes and then click 'Request Survey' again. The URL will stay the same it just allows you to edit, if necessary.
 - 10. Half way down the survey page is a LINK TO RESPOND. This is the URL link voters will click on to access the ballot, so it should be included in the email that is sent out see B below.
- B. Create an email using text similar to that in Attachment B, remembering to select the appropriate intellectual property clause. The URL for the ballot is included in the description that can be found by clicking on the 'view' button in the survey library.



- C. Email the ballot to the appropriate addressee list.
 - 1. Lists of delegates from each member organization are maintained in the following announcement lists by the Forum's Office Manager (announcement lists are distinct from the group forum lists on the portal):

 - 2. Send email for Plenary electronic ballots to the *Principals and Alternates* announcement list.
 - 3. Send email for Committee electronic ballots to the *Principals and Alternates* announcement list and to the relevant committee announcement list. For example, a ballot for approval of a document at the Technical Committee level is sent to the *Principals and Alternates* announcement list and to the *Technical Representatives* announcement list. When conducting a committee ballot, construct a separate ballot and email for the *Principals and Alternates* announcement list and for the committee announcement list.
- D. A file library has been created for each Committee so they can better track the active ballots. The Office Manager will add ballots to this file library at the same time ballot announcements are emailed to the various groups and include the link to the appropriate file in the ballot email. (The document link can be found after the document has been attached to the new ballot file in the library. The link appears below the attached document. This link should be included in the body of the email announcing the ballot see Appendix B and should also be pasted into the description of the Survey Overview see Page 1, A.4.) When the ballot is complete, the Office Manager will remove the ballot from this library. The file libraries can be accessed here:

- E. During the ballot period, relevant chairs (Forum Chair, Committee Chair, Vice-Chairs)can view the ballot results to date by accessing the survey manager at http://groups.winnforum.org/p/su/in/req=MGR. Choose the relevant ballot and click view.
- F. About 1 week before the ballot period ends, the ballot email should be re-sent with a reminder note that the voting will soon be ending.
- G. Following the ballot period, send the results of the ballot to the relevant committee chair and vice-chair, and CC the CEO.



Attachment A Building the Ballot Using the Socious Survey Tool

The Ballot should include the following elements:

- **A.** Header *If you receive this ballot more than one time, please only vote once.*
- **B.** Which organization are you representing for this ballot? Followed by a box with about 50 characters.
- **C.** Title, i.e., *Ballot for*<*Document name*>"
- **D.** A Radio Button for each of the following in this order:
- "Abstain < Document name>"
- "Approve < Document name>"
- "Approve with comments < Document name" (enter comments in boxes below)
- "Disapprove with comments < Document name>" (enter comments in boxes below)
- **E.** Insert a horizontal line
- **F.** Add the following text as a Header:

If you need additional space for comments, please respond directly to <Your email address>

G. Insert 10 comment boxes, each with the following format
